

**INFORMASI SAHAM****STOCK INFORMATION****Kondisi Pasar Modal**

Kinerja pasar modal Indonesia ditutup positif di akhir tahun 2023, walaupun menghadapi berbagai tantangan dari situasi ekonomi global dan politik. Indeks Harga Saham Gabungan (IHSG) ditutup positif pada level 7.303 atau meningkat 6,62% yoy. Berdasarkan release dari Bursa Efek Indonesia disampaikan bahwa terdapat rekor baru dari sisi kapitalisasi pasar tertinggi sepanjang sejarah, yakni mencapai angka Rp 11.762 triliun pada 28 Desember 2023 dan sisi volume transaksi harian tertinggi sepanjang sejarah yakni sebesar 89 miliar lembar saham pada 31 Mei 2023.

Kinerja positif ini juga didukung oleh berbagai indikator seperti stabilitas pasar, aktivitas perdagangan, jumlah penghimpunan dana dan jumlah investor ritel terus meningkat.

Peningkatan ini memberikan dorongan semangat dan optimisme untuk menghadapi tahun 2024 dengan memberikan diversifikasi layanan pasar modal.

**Kinerja saham**

Kinerja saham Perseroan sepanjang tahun 2023 bergerak stabil di tengah ketidakpastian perekonomian domestik dan global. Total volume transaksi sepanjang 2023 sebesar 2.565.800 lembar saham ditutup dengan harga Rp 2.000 per lembar saham.

Sepanjang tahun 2023, tidak terdapat aksi korporasi yang menyebabkan terjadinya perubahan saham seperti pemecahan saham, penggabungan saham, dividen saham, saham bonus, perubahan nilai nominal saham, penerbitan efek konversi serta penambahan dan pengurangan modal. Juga tidak terdapat penghentian sementara perdagangan saham dan/atau proses pembatalan pencatatan saham.

***Capital market conditions***

*Indonesia's capital market performance closed positively at the end of 2023, despite facing various challenges from the global economic and political situation. The Jakarta Composite Index (JCI) closed positively at 7,303 or an increase of 6.62% yoy. Based on a release from the Indonesia Stock Exchange, it was stated that there was a new record in terms of the highest market capitalization in history, reaching Rp 11,762 trillion on 28 December 2023 and the highest daily transaction volume in history of 89 billion shares on 31 May 2023.*

*This positive performance is also supported by various indicators such as market stability, trading activity, the number of funds raised and the number of retail investors continues to increase.*

*This increase provides encouragement and optimism to face 2024 by providing diversified capital market services.*

***Stock performance***

*The Company's stock performance throughout 2023 was stable amidst the uncertainty of the domestic and global economy. Total transaction volume throughout 2023 amounted to 2,565,800 shares closed at Rp 2,000 per share.*

*Throughout 2023, there were no corporate actions that caused changes in shares such as stock splits, stock mergers, stock dividends, bonus shares, changes in par value of shares, issuance of convertible securities and capital increases and decreases. There was also no temporary suspension of share trading and/or de-listing process.*
